

## API LICENSE AGREEMENT

This API License Agreement (“**License Agreement**”) is a binding agreement between Bose Corporation, a Delaware corporation with its principal place of business at The Mountain, Framingham, Massachusetts 01701, on behalf of and for the benefit of itself and its Affiliates (“**Bose**”), and you (as the “**Licensee**”) (each, a “**Party**” and collectively the “**Parties**”). This License Agreement applies to your use of the Bose Materials (as defined below). By using the Bose Materials, you agree to be bound by the terms and conditions of this License Agreement. If you do not agree with and accept the terms and conditions of this License Agreement, you may not use the Bose Materials. If you are accepting this License Agreement on behalf of an entity or organization, you represent and warrant that you have appropriate authority to enter into this License Agreement on behalf of such entity or organization, and references to Licensee shall include and refer to such entity or organization.

### 1. Definitions

- 1.1. “**Affiliate**” of a Party means an entity controlling, controlled by or under common control with such Party.
- 1.2. “**API**” means the Application Programming Interface provided by Bose to enable interoperability between the Bose Equipment and Interfacing Software which is executed on computers or other electronic devices to control the Bose Equipment.
- 1.3. “**Bose**” has the meaning set forth above.
- 1.4. “**Bose Equipment**” means Bose SoundTouch® electronic audio equipment manufactured by or on behalf of Bose and intended for use with the API.
- 1.5. “**Bose Materials**” means the API and the Documentation.
- 1.6. “**Documentation**” means any documentation or specifications made available by Bose in connection with to the API.
- 1.7. “**Interfacing Software**” means one or more software applications developed by or on behalf of Licensee solely to interface with and interoperate with the Bose Equipment through the API.
- 1.8. “**Licensee**” has the meaning set forth above.
- 1.9. “**License Agreement**” has the meaning set forth above.
- 1.10. “**Party**” and/or “**Parties**” has the meaning set forth above.

2. **Grant of License.** Subject to the terms and restrictions set forth in this License Agreement, Bose grants Licensee a limited, revocable, non-exclusive, non-transferrable and non-sublicensable license to use the Bose Materials for the sole purpose of developing Interfacing Software to interface with and interoperate with the Bose Equipment through the API.
3. **Ownership; Restrictions on Use.** As between Bose and Licensee, the Bose Materials and all rights therein are and shall remain the sole and exclusive property of Bose. Licensee agrees to use the API only to the extent of its documented and publicly-disclosed capabilities. Licensee further agrees not to: (a) use or attempt to use the Bose Materials in violation or contravention of any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions; or (b) use or attempt to use the Bose Materials other than as expressly set forth in this License Agreement and the Documentation.

4. **Rights in Interfacing Software.** Bose agrees that it obtains no right, title or interest from Licensee under this License Agreement in or to any Interfacing Software.
5. **Term; Termination.**
  - 5.1. Term. This License Agreement is effective upon Licensee's first use of the Bose Materials and shall continue in effect until terminated as set forth herein. Bose may terminate this License Agreement at any time, at its sole discretion, for any reason, with or without notice.
  - 5.2. Automatic Termination. This License Agreement and all rights granted to Licensee hereunder will immediately and automatically terminate if: (a) Licensee violates any provisions of this License Agreement; (b) Licensee engages in any action which disparages Bose or any of its Affiliates or otherwise devalues the name, logos, trademarks, goodwill, or reputation of Bose or any of its Affiliates; or (c) Licensee brings or threatens to bring any patent claim against Bose or any of its Affiliates (including any cross-claim or counterclaim) to enforce any patents that Licensee alleges are infringed by the Bose Materials.
6. **DISCLAIMER OF WARRANTIES.** THE BOSE MATERIALS ARE PROVIDED "AS IS" AND "AS AVAILABLE" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OF MERCHANTABILITY, ACCURACY, FITNESS FOR A PARTICULAR PURPOSE, TITLE OR NON-INFRINGEMENT, AND BOSE EXPRESSLY DISCLAIMS ALL WARRANTIES AND CONDITIONS OF ANY KIND, EXPRESS OR IMPLIED, TO THE EXTENT ALLOWED BY APPLICABLE LAW. LICENSEE'S USE OF THE BOSE MATERIALS IS AT LICENSEE'S SOLE DISCRETION AND RISK, AND LICENSEE IS SOLELY RESPONSIBLE FOR ANY DAMAGE TO ANY SYSTEM OR DEVICE WHICH MAY ARISE FROM SUCH USE. BOSE MAKES NO WARRANTY OR GUARANTEE THAT LICENSEE'S USE WILL BE UNINTERRUPTED, TIMELY, OR ERROR FREE, OR THAT ANY ERRORS IN THE BOSE MATERIALS WILL BE CORRECTED.
7. **Indemnity.** Licensee agrees that Bose will have no liability whatsoever for any use Licensee makes of the Bose Materials. Licensee agrees to defend, indemnify and hold harmless Bose, its Affiliates and each of their respective officers, directors, employees, agents, advertisers, licensors and partners from and against any and all claims, suits, losses, damages (actual or consequential), liabilities, costs, fees and expenses (including reasonable attorneys' fees) arising out of or related to Licensee's use of the Bose Materials.
8. **LIMITATION OF LIABILITY.** IN NO EVENT AND UNDER NO LEGAL THEORY, WHETHER IN TORT (INCLUDING NEGLIGENCE), CONTRACT, WARRANTY, PRODUCTS LIABILITY, OR OTHERWISE, WILL BOSE OR ANY OF ITS AFFILIATES BE LIABLE FOR ANY DAMAGES, INCLUDING ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR EXEMPLARY DAMAGES ARISING OUT OF OR RELATED TO THIS LICENSE AGREEMENT, THE USE OF THE BOSE MATERIALS, OR ANY INABILITY TO USE THE BOSE MATERIALS, (INCLUDING

WITHOUT LIMITATION LOSS OF GOODWILL, BUSINESS INTERRUPTION, LOST PROFITS OR DATA, FAILURE OR MALFUNCTION OF ANY COMPUTER OR ELECTRONIC SYSTEM, OR ANY OTHER COMMERCIAL DAMAGES OR LOSSES), EVEN IF BOSE OR ANY OF ITS AFFILIATES HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN THE EVENT THAT THE FOREGOING LIMITATION IS NOT ENFORCEABLE WITHIN ANY APPLICABLE JURISDICTION, IN NO EVENT SHALL BOSE'S TOTAL LIABILITY TO LICENSEE UNDER THIS AGREEMENT FOR ANY DAMAGES EXCEED THE GREATER OF (A) THE AMOUNT YOU PAID BOSE IN CONNECTION WITH THIS AGREEMENT AND (B) THE AMOUNT OF FIFTY DOLLARS (\$50.00). THE FOREGOING LIMITATIONS SHALL APPLY EVEN IF ANY REMEDY GRANTED HEREIN FAILS OF ITS ESSENTIAL PURPOSE.

## **9. Updates and Modifications**

9.1. To the Bose Materials. Bose may, at its sole discretion, update or modify the Bose Materials; however, Licensee understands and acknowledges that this License Agreement does not create any obligation on the part of Bose to update or modify the Bose Materials or to provide Licensee with any support or maintenance of the Bose Materials. Licensee further understands that updates or modifications to the Bose Materials may: (a) remove or restrict previously existing functionality; and/or (b) require Licensee to update or modify its Interfacing Software.

9.2. To this License Agreement. Bose may, at its sole discretion, make changes to this License Agreement. In the event of any such changes, Licensee will be responsible for reviewing the modified License Agreement, which will be effective upon first posting by Bose to [developers.bose.com](http://developers.bose.com)] or upon notification to Licensee, and use of the Bose Materials by Licensee following any such notification constitutes Licensee's acceptance of the License Agreement as modified.

10. **Publicity.** This License Agreement does not grant to Licensee any rights to use the names, logos, or trademarks of Bose or any of its Affiliates. Unless otherwise expressly approved by Bose beforehand in writing, Licensee may not make any statement, press release or other public communication regarding this License Agreement or the use of the Bose Materials, nor may Licensee state or imply any endorsement by Bose or any of its Affiliates of Licensee or of any Interfacing Software.

11. **Disclaimers and Notices.** In any distribution of the Interfacing Software, Licensee will retain and reproduce in their entirety any disclaimers, copyright notices, or other proprietary notices, if any, provided with the Bose Materials.

12. **Survival.** The terms of Sections 3, 6, 7, 8, 10 and 13 shall survive the termination of this License Agreement along with any terms which by their nature would survive such termination.

## **13. Miscellaneous**

- 13.1. Entire Agreement. This License Agreement constitutes the entire agreement between Bose and Licensee and supersedes any prior agreements relating to the subject matter hereof between Bose and Licensee.
- 13.2. Assignment. This License Agreement and the rights and obligations hereunder may not be assigned or delegated by Licensee without the prior written consent of Bose, which may be withheld at the sole discretion of Bose.
- 13.3. No Third-Party Beneficiaries. Other than as expressly set forth herein, no person or entity not a party to this License Agreement will be a third-party beneficiary of this License Agreement.
- 13.4. Jurisdiction, Venue and Choice of Law. This License Agreement will be governed by and construed according to the laws of the State of Massachusetts, without reference to its conflict of laws provisions. The parties agree to submit to the personal and exclusive jurisdiction of the state and federal courts located in the City of Boston, Massachusetts.
- 13.5. Waiver. The failure of Bose to exercise or enforce any right or provision of this License Agreement will not constitute a waiver of such right or provision.
- 13.6. Severability. If any provision of this License Agreement is found by a court of competent jurisdiction to be invalid or unenforceable, then that provision will be removed from this License Agreement and the remaining provisions will remain in full force and effect.
- 13.7. Government Use. Licensee agrees that the Bose Materials are a “Commercial Item”, consisting of “commercial computer software”, and “commercial computer software documentation” as those terms are defined in the Federal Acquisition Regulations and the Defense Federal Acquisition Regulations, as applicable. The Bose Materials are being licensed to, and any use of the Bose Materials by the U.S. Government shall be governed by the terms of this License Agreement.
- 13.8. Equitable Remedies. Licensee acknowledges that Licensee's breach of the license or use restrictions in this Agreement may cause Bose irreparable harm. Thus, Licensee agrees that, in addition to any other rights or remedies available under applicable law, Bose shall have the right to immediate injunctive relief in the event of any such breach.
